In preparing for the upcoming hearing, we have identified certain errors that we made in preparing the Part 2 Submission of Fairborne Energy Ltd. (Exhibit 06-023-2006-08-25).

In order to correct those errors, enclosed for filing on behalf of Fairborne are:

- Revised summary sheets for each of Appendix A, Schedules 1 through 3 of the Part 2 Submission of Fairborne Energy Ltd. The revised summary sheets are intended to replace their original counterparts. Exhibit number 06-027-2006-10-12 has been preassigned to the package of revised summary sheets.
- Blacklined versions of the revised summary sheets mentioned in the previous bullet that highlight the revisions that have been made to the original documents. Exhibit number 06-028-2006-10-12 has been preassigned to the package of blacklined revised summary sheets. No revisions have been made to the summary sheet for Schedule 2 other than to delete the "Privileged and Confidential Draft: August 23, 2006" heading that appeared on the original. That same revision was made to the summary sheets for Schedules 1 and 3. The other revisions to the summary sheets for Schedules 1 and 3 are highlighted with the blacklining.
- A copy of the Option and Petroleum and Natural Gas Lease, dated May 2, 1956 between Neil A. McLeod and Ted Harris as to an undivided 2/3 interest in the North Half (N½) of Section Thirty-Five (35) within, upon or under all of 39-24 W4M, and as described in Title No. 76 Q 131, of all the petroleum, natural gas and

related hydrocarbons, except coal. As noted in the revised summary sheet, the Option and Petroleum and Natural Gas Lease now forms part of Schedule 1. Exhibit number 06-029-2006-10-12 has been preassigned to the document.
