Husky has reviewed the letter from counsel for EnCana dated March 14, 2007 (EnCana Letter) and has the following comments. Husky requests that the Board disregard the new information filed by EnCana following the close of the record in this proceeding.

In responding to Undertaking No. 2, Husky has provided the information specifically requested and has repeated comments made previously in its January 30 and February 14, 2006 submissions. Husky did not introduce any new information, other than as was required to respond to the undertaking.

EnCana misconstrues what the Board requested in its undertaking and inappropriately uses the opportunity to submit further evidence. Nothing in Husky's response to the undertaking given during the proceeding either invited or required EnCana's filing of the tables and figures, attached to the EnCana Letter and described in the third numbered paragraph of that letter

The public interest in the finality of Board hearing processes and procedural fairness to all parties requires that the Board reject attempts by parties to file additional information after the close of the record in a proceeding.
